He stated that Councilman Franks relentless complaints about or to the Police over the years, as well as other complaints levied against fellow residents, were extremely excessive. Mayor Nohilly shared that Councilman Franks called the Police Chief again without going through the appropriate authority.

Mayor Nohilly discussed Councilman Frank's wife's use of social media that included comments about the Mayor's son and Councilman Delia's children. Mayor Nohilly explained that though Councilman Franks cannot control what his wife does or says, it reflects badly on him as a Councilmember.

Councilman Franks responded that he does not control, nor does he want to, his wife and her actions. He also stated he contacted the Chief to clarify the 15 mph perception comments that were made at the last meeting. He also contacted former Chief Todd and a former Interlaken Police Officer to confirm their ticket writing in the past. He stated he always sends concerns to BA Reibrich, as she is the appropriate authority. He stated that the comments made by Mayor Nohilly mean nothing to him because he feels he is serving the Interlaken residents well.

Councilman Delia thanked Mayor Nohilly for his statement and said that he was in full agreement with the comments made regarding the conduct of Councilman Franks.
